 - i. Mr. Scott shared the financial DCOH 128, the debt ratio is covered. Several budgets are under spent. Revenues are slightly under budget. The federal grant did not come through. Budgets will level by year-end. Supplemental budget for two schools, Northern Denver and Grand Junction.

b. Headmaster Reports.

- i. Dr. Tacoma provided an update from Northern Denver. Fundraising Gala raised \$61k for the school. CMAS window closed and testing is complete. Many events, including fieldtrips, are taking place. Continuations taking place at the end of May.
- ii. Mr. Jones provided an update from Douglas County. CMAS was completed, DIBELS and MAPS testing still to complete. Spring fun run grossed \$60k+, with the intention to purchase an additional bus. Staff meeting and coffee with the administration next week. New staff coming in (Deans and Asst. HM) for introductions. 27 Sr. students who have been offered over \$3m in scholarships. Enrollment is strong with projection of 800+ students. HSE is looking good.
- iii. Ms. Hiatt provided the HM update for Northern Colorado. Hosting support provider at the campus this week. Annual fundraising grossed over \$92k. Finalizing hiring for the year. Graduating first

- senior class, looking forward to building traditions. 96% participation on CMAS, much higher than in the past. Enrollment is strong with 10 new upperclassmen.
- iv. Ms. Drake provided the update from Grand Junction. CMAS testing was completed. Last Friday was the first school play performance. Latin exam participation with several medals earned. Music performances and art walks taking place. House induction taking place. Dean of Grammar School hired and will be coming from AZ. CSI renewal. 96% of projected enrollment goal.
